Iwi Registration Application

Objective: To create an Iwi Membership Register of the descendants of the Hapu of Ngati Maru Iwi.

Entitlement to Membership

Only the following persons are entitled to apply for membership of Te Runanga o Ngati Maru Iwi Inc.

- a. Ngati Maru descendants
- b. Partners of Ngati Maru descendants
- c. Whangai of Ngati Maru descendants
- d. Descendants of the whangai of Ngati Maru descendants

Applications for Membership

1. All applications for membership shall be in writing and signed by the applicant.
2. Applications for membership on behalf of children may be signed by their parents or legal guardian.
3. All completed applications are to be sent to the secretary, Te Runanga o Ngati Maru Iwi Inc., PO Box 37, Thames.
4. Bulk applications are acceptable, but must provide all relevant details as per the official application form.
5. All application shall undergo an internal validation process by Hapu Representative or Kaumatua.
6. Upon validation, all applicants shall forthwith become members of Te Runanga o Ngati Maru Iwi Inc. with all rights and obligations to such membership.
7. All information contained in the application forms remains confidential to Ngati Maru.

The Register

The register of all members of Te Runanga o Ngati Maru Inc. and their contact address and phone number shall be kept by the secretary and the names of all new application shall be added to the register upon successful application.

It is the responsibility of each member, their parent or guardian to advise the secretary of any change of contact address or phone number.

Termination of Membership

Any member may resign from Te Runanga o Ngati Maru Iwi Inc. at any time by notice in writing to the secretary and such member's membership of Ngati Maru shall terminate forthwith from the date that the resignation is received by the secretary. However, such resignation does not preclude that person re-applying for membership.

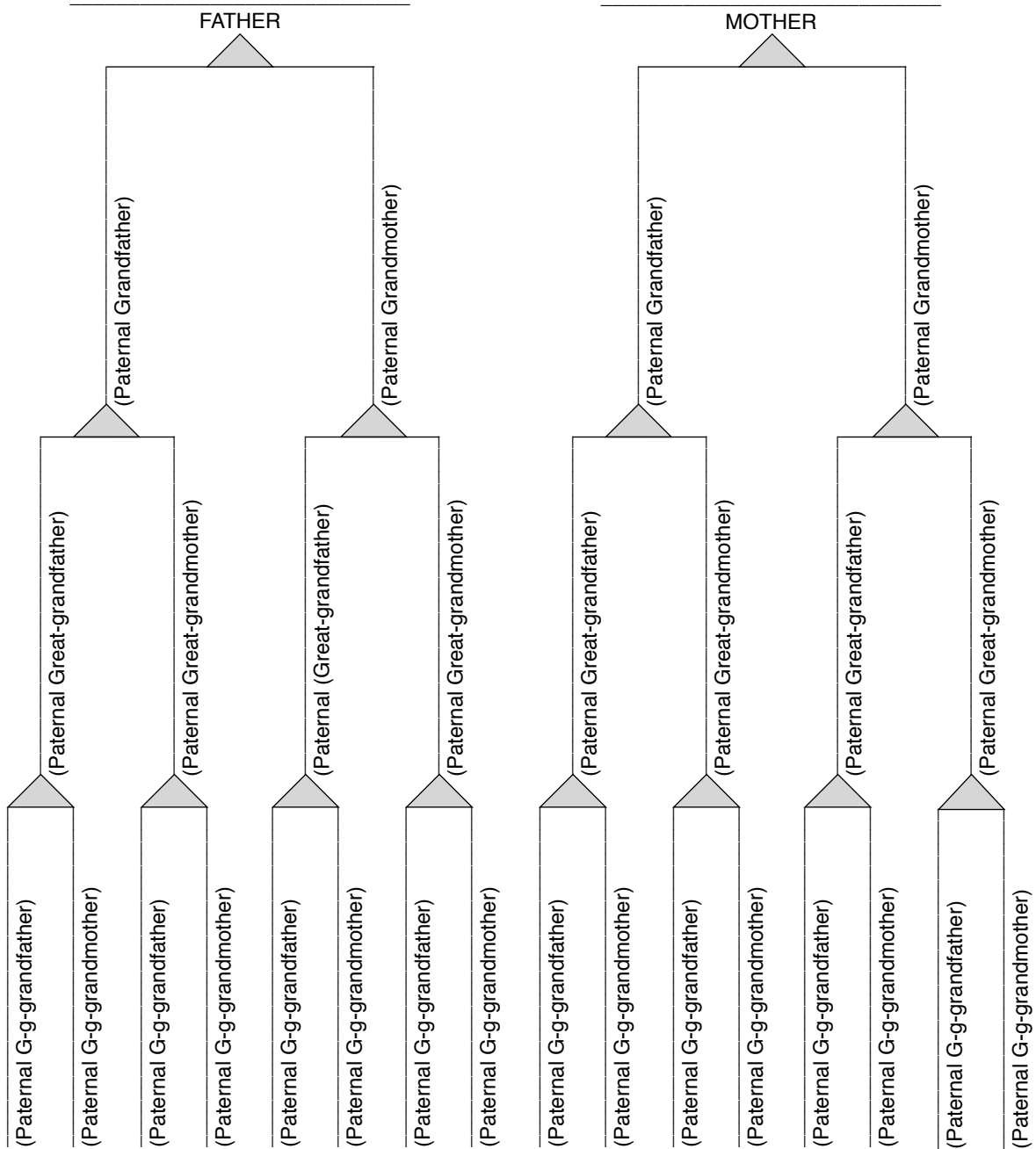
