The mandated Treaty negotiators for Ngāti Maru have negotiated a Deed of Settlement with the Crown, and voting is now open.

**The voting period is Saturday, 22 September 2018 to noon, Friday 2 November 2018.**

The resolution to be voted on by Ngāti Maru is:

1. I support the Ngāti Maru Deed of Settlement.
